About the Rain Gardens

In early 2011, the Clark County Soil and Water Conservation District (SWCD) submitted an application to the Indiana American Water Environmental Grant Program to establish *Reading Rain Gardens for Water Quality* within the Silver Creek watershed. In June 2011, Indiana American Water awarded a grant to the SWCD. The SWCD began work immediately to install the three gardens pictured in this brochure.

Each Reading Rain Garden includes native trees and plantings, and a bench to afford people the opportunity to sit, read, and relax while enjoying the view of each garden. In addition, books about water quality and rain gardens are available for loan at the Sellersburg Library location.

What Rain Gardens Do

Rain gardens reduce the amount of pollution in nearby streams and waterways by providing areas for stormwater runoff from impervious surfaces to be absorbed into the soil. Stormwater flows from hard surfaces such as roofs and driveways, into storm pipes, drainage channels, and streams. It collects harmful oil-based products, lawn chemicals, pesticides, pet waste, and toxic substances. When these containments reach our water supplies they harm fish and wildlife, kill native vegetation, and make recreational areas unsafe. Our Reading Rain Gardens absorb runoff from the roofs of nearby buildings.
